Effective risk management in outpatient methadone treatment	Institute for Research, Education & Training in Addictions	The one-day training "Effective Risk Management Strategies in Outpatient Methadone Treatment" is designed to increase opioid treatment providers' knowledge and skills on the most effective ways to conduct risk management strategies for opioid treatment centers. Describe and heighten awareness for best practices and the need for increased vigilance of patient safety with methadone treatment. Improve ability to identify and access and manage risks. Employ an in-depth understanding of the clinical issues for safe induction, dosing, assessment of impairment and cardiac factors, etc. that can strengthen patient safety and improve care. Assess and expand the knowledge of current trends in opioid treatment. Medication Assisted Treatment Course	National Drug Court Institute (NDCI)	Online training curriculum designed to educate drug court professionals on medication assisted treatments (MAT) for substance use disorders with a major focus on opioid use disorders. The presentation will explore the various issues that arise in the implementation and utilization of Medication Assisted Treatment (MAT), including access to medications, duration of medication usage, coordination of providers, and the interaction between MAT, psychosocial counseling and fellowship support groups. Discussion will focus on anticipating barriers to evidence-based treatment of OUD. This course is designed to provide an overview of the addictive process and basic knowledge, attitudes and skills utilized by professionals from a variety of backgrounds who work with clients experiencing substance use disorders.
